Provider impact report

This impact report summarises the progress made by The University of Surrey against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

1. Ambition and strategy

The University of Surrey's ambition and strategy as detailed in the 2019-20 access and participation plan:

At a strategic level, we are committed to provide a whole institution approach to access and participation, that supports the individual needs of learners across the student lifecycle and is underpinned by a robust approach to evaluation. We aim to offer a high-quality education and experience to all our students. This commitment is articulated throughout our 19/20 Access and Participation Plan, with section 2 of the plan focused on how we implement our strategy and ambition.

To continue to deliver on our plan, we have ensured that Access and Participation remains a strategic focus of the University, with appropriate governance and accountability structures in place. As such, we have an Access and Participation Advisory Group (APAG) to ensure that there is a coordinated and systematised approach to the delivery and evaluation of Access & Participation activity. The APAG reports directly to the Access and Participation Governance Panel, which is chaired by the Pro-Vice Chancellor Education and provides regular updates to Executive Board and the University Council. The Governance Panel provides senior and executive level oversight of delivery against targets and includes membership of the Student Union president.

The 19/20 plan also details our strategic focus on being data and outcomes led and includes several milestones and targets that were developed based on differential performance research that we undertook to better inform our practice. Evaluation continues to be a critical aspect to our work and the plan demonstrates this through providing information on our logic model evaluation framework, the use of a traffic light system to mitigate risk and assess which activities have met their intended outcomes, and longer-term approaches to evaluating impact, including our use of HEAT and our longitudinal study of our work with Kings College, Guildford.

How have you met the commitments in your plan related to this target?
Achieved 7.4% in 2018/19 which has dropped to 6.8%, a 0.6 percentage point decrease. The figure is 1.1 percentage points below our location benchmark of 7.9%.

Contextualised offer scheme is being developed, with the aim to implement for 2022/23 entry. This will include POLAR4 Q1 as one of a number of key eligibility criteria.
