Clearing 2025 Prize Draw Terms and Conditions

By entering the Clearing 2025 prize draw ("**Prize Draw**"), entrants confirm that they have read and agree to be bound by these terms and conditions. If an entrant is under the age of 18, the entrant confirms that their parent/guardian agrees to be bound by these terms and conditions.

- 1. The Prize Draw is held by the University of Surrey, Guildford, Surrey, GU2 7XH (the "University").
- 2. The Prize Draw is open to all prospective students who register for Clearing 2025 at the University and are resident in the United Kingdom, except for: employees of the University and their immediate family members; agents; or any third party directly associated with the administration of the Prize Draw. For the avoidance of doubt, entrants do not have to accept a place at the University through Clearing 2025 in order to be eligible for the Prize Draw.
- 3. By entering the Prize Draw you confirm that you are eligible to do so. The University may require you to provide proof that you are eligible to enter the Prize Draw.
- 4. The Prize Draw is free to enter.
- 5. The Prize Draw is open to entries from 1 May 2025.
- 6. All entries must be submitted by 23:59 on 14 August 2025. Any entries received after this time will not be entered into the Prize Draw.
- 7. Only one entry per person is permitted.
- 8. Members of the University's Student Marketing team, supervised by an independent person, will conduct the Prize Draw and randomly select the winning entry after 14 August 2025. There will only one winner and one prize available.
- 9. The University's decision will be final, and no correspondence or discussion will be entered into.
- 10. The winner will be notified via email during the week commencing 1 September 2025. The winner must provide their email address or postal address to the University to receive their prize.
- 11. The winners will also be announced on the University's digital platforms.
- 12. The prize will be 1 Hydroponics Growing System including herb seeds and pods. The University reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond the University's reasonable control make it necessary to do so. This will be sent/posted within 14 working days of notification.
- 13. The prize is non-exchangeable, non-transferable and no cash alternative is offered.
- 14. Personal data supplied for the Prize Draw will only be processed as set out in the University's Privacy Notice: https://www.surrey.ac.uk/information-governance/privacy-notices/prospective-student-privacy-notice. For children under 18 years old, consent from a person holding parental responsibility is required. By entering, entrants agree that any personal information provided with their entry may be held and used by the University or its agents and suppliers to administer the Prize Draw.
- 15. The University does not accept responsibility for network, computer, software, or technical failures of any kind and has no responsibility for lost, delayed, or misdirected entries.
- 16. The University reserves the right to refuse entry or refuse to award the prize to anyone in breach of these terms and conditions.
