The appeal should be submitted within 10 working days of notification of the decision and/or penalty being appealed. You may wish to obtain advice on your case before submitting an appeal. The Students' Union offers an independent, impartial, confidential support service to all students. The office supports students who wish to make an appeal or launch a complaint, and is also there to help students with welfare or education problems.
